





Golden Visa

黄金签证

房地产投资者购买价值等于或超过200万迪拉姆，即可申请10年可续签的黄金签证，并可担保其配偶和子女办理居留签证。

Real estate investor who owns a property equal valued at AED 2,000,000 or more at the time of purchase can apply for a 10 years renewable residency visa, and the husband or wife and children can be sponsored.

Applying for a golden visa without a property

在不购置房产的请款下，宸康國際可协助您办理黄金签证。申请人需满足高薪高职位要求(就 职于阿联酋公司，月薪不低于30,000迪拉姆，且六个月银行流水不断累积上升)。

Supreme International can assist you with Golden Visa application without purchasing a property. The applicant is required to take a high position in a UAE company with a minimum salary of 30,000AED, and his/her bank statement should show an accumulation of wealth.
